General Terms & Conditions

Offer and redemption

This Promotion is valid from 3:00pm on 4 June 2018 to 11:59pm 1 July 2018 Singapore Standard Time ("Promotion Period").

This Promotion is open to all Deliveroo Rider-Partners ("Rider-Partners"). Rider-Partners are active Deliveroo riders based in Singapore.
